This variable is a sequential number that identifies the order of short-term co-residents as they were listed by the interviewer within any one case at the time of the 2003 interview. In combination with STC2, this variable forms a unique identifier for each record on the file.

-	-	229 - 399	Individuals who moved into a core family for the first time after the 1968 interview or who have no sample parent; individuals from the Immigrant sample, other than the spouse of a 1997 (or 1999) Head, who moved out in the year preceding the 1997 (or 1999) interview or who moved in for the first time after the 1997 (or 1999) interview. These individuals are nonsample unless they were born after the initial wave and have at least one sample parent. This series is simply a continuation of the 170-226 group.
