For Release 2, we have not made any changes to Pregnancy Intentions file but updated the release number to synchronize with Release 2 of the Child Birth and Adoption History file.

Section I: Overview of the 2013-2023 Pregnancy Intentions File

Beginning in the 2013 Wave, a new series of questions about future pregnancy intentions was added. It was asked of those respondents who are the biological parents of newborns reported since the last interview. The series of questions asks about the respondent's and his/her spouse or partner's intentions (if there was one present in the family unit) to have more children.

We have continued this question series since 2013 and in 2023 the number of questions was expanded to include questions on contraception methods. Additionally, as of 2023, the number of individuals it is asked of now includes not only respondents who are parents of newborns but also includes respondents who are Reference Person or Spouse/Partners and are eligible to be asked the birth history section. This file is cumulative as new reports are added, by wave. The same individual may have multiple reports over time but a maximum of one report, per wave.

As of 2017 forward, Boyfriends and Girlfriends were included in other parent categories for this series (OS66CKPT, OS66, and OS70). For waves 2013-2015, OS70 was asked of everyone; as of 2017 forward, this question is not asked for those who do not want or cannot have more children.

Individuals for Whom the Data are Available

Data are available for respondents who reported being the biological parent of a newborn reported in Section J of the questionnaire. As of 2023, this section is also being asked of respondents who are Reference Persons or Spouse partners and are eligible to be asked the birth history section regardless if they are parents of a newborn child. Those eligible for birth history reporting are Reference Persons, Spouses/Partners, and Other Family Unit Members (OFUMs) age 15-44 years old. Users may want to note the complex flow of this section starting at the J1Checkpoint.

Section III: Structure of the File

Number of Records

The 2013-2023 Pregnancy Intentions File contains a total of 9,164 records. The structure of the file is one record per person, per wave. Multiple records for a given parent can result from an individual reporting a newborn child in more than one wave.

Sort Order of the File

The file is sorted by three variables: "1968 Interview Number" (PGINT2), "Person Number" (PGINT3), and descending "Year of Report" (PGINT4). Combine these three variables to create a unique record primary key.

Variables on the File

The File contains 46 variables, some of which are about the responding parent and some about the respondent's spouse or partner (or boyfriend or girlfriend, as of 2017), if he/she was residing in the Family Unit at the time of the interview.

What Cross-Year File to Use for Merging

The 2013-2023 Pregnancy Intentions File merges with the 1968-2023 Public Release Individual File exactly. If one attempts to merge the 2013-2023 Pregnancy Intentions File with an earlier Individual file, some cases on the Individual File may not match. The following variables on the Pregnancy Intentions File correspond to the Individual File as such:

PGINT2=ER30001

PGINT3=ER30002

The user should note that an individual may have more than one record on the Pregnancy Intentions file and may want to subset records by year of the report.

Section IV: Linking Records

When matching the 2013-2023 Pregnancy Intentions File to individual data, only the 1968-2023 Individual File should be used. During file merging and cleaning, a number of unique individual identifiers were corrected. Special care was taken to ensure perfect correspondence in individual identifiers between this file and the 1968-2023 Individual File.

Because of these corrections, do not attempt to match this file using these unique individual identifiers to any other PSID data file or a derived subset, using these unique individual identifiers. Non-matches in individual records will occur if any file other than the above-named is used.

Data processing is required to link records between these two files. To achieve linkages, one must match on the parent's unique individual-specific identifier. This unique person identifier is a

combination of two variables: "1968 Family Interview Number" (PGINT2) and "Person Number" (PGINT3). The corresponding variables for these identifiers on the cross-year Individual File are ER30001 and ER30002.

Section V: Codebook

The item-by-item descriptions for all of the variables in the 2013-2023 Pregnancy Intentions File can be found in the codebook. Unweighted frequencies were calculated for each variable.
